Re:	HIV-1 Nucleic Acid Testing (NAT)

Effective Monday, March 20, 2023, the North Carolina State Laboratory of Public Health (NCSLPH) will resume HIV nucleic acid testing (NAT) in-house on the Hologic Panther instrument platform. However, prenatal specimens will still be forwarded to the Association of Public Health Laboratories (APHL)/Centers of Disease Control and Prevention (CDC) HIV NAT Reference Center at the New York State Department of Health Wadsworth Center. As described in the <u>CDC Recommended Laboratory HIV Testing Algorithm</u>, NAT testing is only initiated for the small number of specimens with a reactive antigen/antibody combination test and an indeterminate or negative HIV-1/HIV-2 differentiation test.

There will be no change to specimen collection or submission procedures related to this change. Submitters should continue submitting specimens with the <u>HIV/HCV Testing Report Form, DHHS 1111</u>. Additional information about submission criteria and shipping can be found in Appendix A of the <u>NCSLPH SCOPE Guide</u> to <u>Laboratory Services</u>. Submitters may notice minor formatting changes and updated comments on results reports and we appreciate your patience during this transition.
